4. Court costs of \$105.00 (which reflects a \$10.00 waiver discount) are included in the above waiver amounts also included are State costs of \$39.00 and Cuyahoga County costs of \$5.00.
5. **Seat belt waiver amounts include Court Costs of \$71.00 (which reflects a \$10.00 waiver discount, State Costs of \$10.00). In accordance with O.R.C. 4513.263 and fines are \$30.00 for driver and \$20.00 for passengers.**
