NEW EQUIPMENT

The Village recently purchased new equipment to help improve snow removal (see photos to the right).

DISPOSAL INFORMATION

Please place all disposables in an orderly fashion on tree lawn.

- Old cans of paint, pesticides, & other hazardous household chemicals, phone books & computer equipment may also be placed out for collection.
- NO LATEX PAINT. To dispose of it, just open the lid to let the paint dry out and become a solid. Then put it out with your regular trash.

FALL LEAF COLLECTION

The North Randall Service Department will begin its FALL PROGRAM in MID-OCTOBER. Rake leaves onto your tree lawn and remove branches, twigs, rocks and other debris. Piles that contain items other than leaves WILL NOT be picked up. If you have branches or brush, you may tie them into small bundles no more than 4-feet long. Do not place leaves in the roadway. The Service Department will make recurring trips around the Village until the weather becomes inclement.







BUILDING DEPARTMENT

CHARLES HORVATH, BUILDING COMMISSIONER

IT IS TIME TO START THINKING ABOUT TAKING CARE OF YOUR HOUSE FOR THE WINTER.

HERE ARE SOME IMPORTNAT THINGS YOU SHOULD REMEMBER:

- 1. Clean the gutters after all the leaves have fallen
- 2. Remove any overhanging tree branches that could damage the roof shingles
- 3. Have your furnace cleaned and serviced
- 4. Have your clothes dryer vent system cleaned of flammable lint accumulation
- 5. Have your roof checked for missing shingles, loose flashing, etc.
- 6.Check the batteries in all smoke detectors and carbon monoxide detectors. THEY SAVE LIVES
- 7. REMEMBER- make sure any contractors you have doing work get the necessary permits from our building department. Ask to see the permit, and feel free to call me on my cell phone (216-244-4274) to verify that they are in compliance with Village Ordinances.

**Don't use rock salt on any concrete or masonry areas. Use CALCIUM CHLORIDE pellets or flakes for ice removal **



CUYAHOGA COUNTY BOARD OF ELECTIONS

Dates, Deadlines and New Rules for Voting

October 11th: The Board of Elections will begin mailing ballots to voters who have submitted Vote-by-Mail ballot applications.

New Rule: the deadline to submit Vote-by-Mail ballot applications has changed. Vote-by-Mail ballot applications must be received by the Board of Elections on or before **October 31st.**

Vote-by-Mail ballots must be postmarked on or before **November 6th**. Hand delivered ballots may be dropped off at the Board of Elections until 7:30 p.m. on Election Day.

Voting Location Changes: Your voting location may have been changed for the November 7, 2023 General Election. Voters are encouraged to confirm their voting location when making their voting plans. Confirm your voting location at **www.443vote.us** or by calling **216-443-VOTE** (8683).

New Rules for Early In-Person Voting: Photo identification is required when Early In-Person Voting. The identification requirements for Early In-Person Voting are now the same as when voting on Election Day.

Voting hours: Your polling location will be open on Election Day from 6:30 a.m. to 7:30 p.m.

What ID should I bring?

Acceptable forms of unexpired photo ID include:

THE NOVEMBER 7, 2023 GENERAL ELECTION

There are two statewide issues, a countywide issue and municipal issues on the November 7, 2023 General Election ballot. In addition, voters will elect municipal, school board and judicial candidates.

Voters who wish to Vote-by-Mail must complete and submit a ballot application. To request a Vote-by-Mail ballot application visit: www.443vote.us or call 216-443-VOTE (8683). Vote-by-Mail ballot applications are also available at all public libraries.

Early In-Person Voting begins on October 11, 2023. Early In-Person voting hours are posted on the Board of Elections website.

On Election Day the polls are open from 6:30 a.m. to 7:30 p.m. Voters are advised to confirm their voting location on the Board of Elections website: www.443vote.us or by calling 216-443-VOTE (8683). Voters are reminded to bring photo identification when voting Early In-Person or when voting on Election Day.

NEW TRAFFIC UNIT

Hello. My name is Antonio F. Stitt. I am the Acting Chief of Police for our community. As I'm sure you are well aware, the community is growing. As we grow, the influx of people traveling and moving about throughout our community is also growing. With that, comes a need for adjustments in how we police. We are creating a "Traffic Unit". This unit will focus on traffic enforcement only. As it stands, officers periodically enforce traffic laws during their shift.

Going forward, shift-officers will not focus on traffic enforcement. Instead, they'll focus more on foot patrols, building checks, more direct interaction with residence and patrons that reside and interact in our community. The traffic unit will operate during designated high traffic locations and times. It will not operate daily. It will operate systematically unsystematic.

COMMUNITY FIRST

Furthermore, policing trends suggest we change our policing style from focusing largely on addressing the criminal element, to focusing (Not All) but, more on the "Community First" style of policing. Focusing more on relationship building with people and learning how we can better serve the people in our community. To assist in initiating this new concept, my administration will be adjusting our operational standards to support the "Community First" narrative. Also, we'll initiate focused conversation geared towards positively impacting officer mind-set and attitude.



NORTH RANDALL FIRE DEPARTMENT



Over the past few months, the North Randall Fire Department has participated in multiple Public Relations events including YMCA Family Days in Warrensville Heights and the Unity Fest in North Randall.

We are preparing for more events such as Thistledown Family Days September 23rd, Village Hall Grand Opening, and the Second Annual Thistledown Mud Run on October 15th.

Before You Light It... Know Ohio's Open Burning Regulations

Why is open burning a problem?

Open burning can release many kinds of toxic fumes. Leaves and plant materials send aloft millions of spores when they catch fire, causing many people with allergies to have difficulty breathing.

The pollutants released by open burning also make it more difficult to meet health-based air quality standards, especially in or near large cities. The gases released by open burning can also corrode metal siding and damage paint on buildings.

What open burning is never allowed?

Under Ohio law, these materials may not be burned anywhere in the state at any time:

- garbage-any wastes created in the process of handling, preparing, cooking or consuming
- materials containing rubber, grease and asphalt or made from petroleum, such as tires, cars and auto parts, plastics or plasticcoated wire: and
- dead animals—unless approved for control of disease by a governing agency.

Other restrictions:

- Open burning is not allowed when air pollution warnings, alerts or emergencies are in effect.
- · Fires cannot obscure visibility for roadways, railroad tracks or air fields
- No wastes generated off the premises may be burned. For example, a tree trimming contractor may not haul branches and limbs to another site to burn.

Does Ohio EPA ever allow exceptions to the rules?

Under certain circumstances, yes. However, to burn a prohibited material or set a fire in a restricted area, you must receive written permission from Ohio EPA before you begin burning. This may take two weeks.

Can a community regulate open burning?

Yes. However, local ordinances cannot be less strict than the state law.

What happens if I'm caught illegally open burning?

Ohio EPA has the authority to enforce the state's open burning laws. Violations can result in substantial penalties. If you have any questions, or would like to report a suspected open burning incident, contact your Ohio EPA district office or your local air pollution control agency. See the map in this brochure for the agency to contact in vour area.

Health Concerns

Burning household waste produces many toxic chemicals and is one of the largest known sources of dioxin in the nation. Other air pollutants from open burning include particulate matter, sulfur dioxide, lead and mercury.

These pollutants have been linked to several health problems, including asthma, respiratory illnesses, nervous system damage, kidney and liver damage, and reproductive or developmental disorders.



What You Can Do **Instead of Open Burning**

- Reduce the amount of waste you generate.
- Reuse items in another way.
- Recycle Contact your waste disposal provider about curb-side pickup or drop-off locations for bulky or hazardous items.
- Compost yard trimmings and food scraps, while creating a natural, free fertilizer.

Before You Light It... Know Ohio's **Open Burning** Regulations

Open burning is any time you light an outdoor fire without a chimney or stack.

When burning refuse in burn barrels or open piles, the potential cost to your health, your home, your neighbors and your environment far exceeds the price of adequate collection services.

A representative from the FD will contact you to arrange a time for the FD to come out and install your detector(s).

All smoke detectors must be installed by NRFD personnel.

If you presently have a working smoke detector, please **DO NOT** order new ones. Due to recent supply issues, supplies are limited.
